DEVELOPMENT OF INDUSTRIAL CITIES

2774. SHRI G.V.L. NARASIMHA RAO:

Will the Minister of **Commerce and Industry** be pleased to state:

- (a) how many Industrial Corridors are under development in the country, the details thereof;
- (b) how many industrial cities or projects are proposed for development under each of the above Corridors;
- (c) the details for each Corridor like location, State, likely year of initiation, proposed area, nature of industrial development, likely investment, etc.;
- (d) how many industrial cities/nodes are proposed for development in Andhra Pradesh, Telangana, Tamil Nadu, Kerala and Karnataka, the details thereof;
- (e) which two States have the highest number of industrial cities/nodes proposed for development; and
- (f) the reasons for their preference?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE & INDUSTRY (SHRI SOM PARKASH)

(a) to (f): Government of India has accorded approval for development of 11 corridors (32 projects) in four Phases as part of National Master Plan for providing multimodal connectivity to economic zones which are under various stages of conceptualization/development/implementation. The list of Industrial Corridors/projects in the respective states along with status of implementation is attached at **Annexure**. The nature of industrial corridor development is to provide plug n play infrastructure at the plot level for expanding the industrial output, increasing investment, employment opportunities and to provide better living and social facilities for the new and growing workforce.

Under Delhi Mumbai Industrial Corridor (DMIC), implementation activities are underway in the 04 nodes, namely, Dholera Special Investment Region in Gujarat (Phase I 22.5 sq. kms), Shendra-Bidkin Industrial Area in Maharashtra (Phase I 40 sq kms), Vikram Udyogpuri Project (1100 acres) and Integrated Industrial Township in Greater Noida (745 acres). Total of 93 plots has been allotted in these 4 cities/nodes with likely investment of over Rs. 16,000 crore.
